## BOLSA MEXICANA DE VALORES, S.A.B. DE C.V. INFORMS:

The list of the 55 first stock series according to IPC's Eligibility criteria, with data available as of **August 2014** close.

The calculation in order to determine the eligible securities ranking for the Prices and Quotations Index (MexBol) constituent list with data available as of **August 2014** close, has been made in strict compliance with the Injunctive Relief issued by the Sixth Civil Judge from the Mexican Federal District Higher Court. As a consequence, in this ranking, ELEKTRA will be assessed using the previous methodology, without the adjustments announced on April 11, 2012, so that it won't be affected either directly or indirectly. For the remaining securities, BMV applied the methodology considering the adjustments announced on April 11, 2012, and incorporating the updates announced until September 1<sup>st</sup> 2014, approved at its time by BMV's Technical Committee of Indices Methodologies.
