Exchange Rates:

S&P DJI and the BMV are proposing to change the foreign exchange rates used in the official close index calculation of several BMV indices. Currently, BMV uses the Mexican peso/ U.S. dollar midmarket spot exchange rate, know as "MXN =", and is provided in a real time basis by Thomson Reuters to calculate the indices. S&P DJI and the BMV are proposing to change the index calculation to use one of the following exchange rates for official close index calculation only. For real time index calculations, the indices will use Thomson Reuters Spot Rates i.e. RICs MXN=, USD=:

- WM/Reuters foreign exchange rates taken daily at 16:00 hours London Time. These midmarket fixings are calculated by The WM Company based on Thomson Reuters data (USDMXNFIXM=WM).
- WM/Reuters Spot foreign exchange rate taken daily at 16:00 hours New York Time (USDMXNFIXMP=WM). WM rates are S&P's standard FX Provider and the industry standard globally.
- Banxico Exchange Rate Fix 48 Hours. The exchange rate applicable to liabilities denominated in foreign currency and payable in Mexican Pesos within Mexican territory. http://www.banxico.org.mx/repositorios/dgobc-web/sisfix/fix48-en.html
- Valmer Spot Exchange Rate. The exchange rate applicable to liabilities denominated in foreign currency and payable in Mexican Pesos within Mexican territory determined by the Price Vendor (Valmer) using Reuters Information with the RIC, Dealing 3000 Treaded (MXN=D3) at 13:30 hours Mexico Time. http://valmer.com.mx/en/
