Further, the Board has decided to suspend the subscription, conversions and the redemption of shares within the Share Class as from June 5, 2024 15-30 CET on the Primary Market. On the Primary Market, the shareholders of the Share Class (the Shareholders) may therefore continue to request the redemption of their shares free of charge in accordance with the provisions of the Prospectus until June 5, 2024 15-30 CET. On the Secondary Market, the Board has decided to delist the shares from all of the stock exchanges on which they are listed from May 30, 2024 after the close of the relevant stock exchanges.

Therefore, the last trading day (purchase-sale) of the shares of this Share Class on the stock exchanges on which they are listed will be May 30, 2024, until close of business. For shares sold on any exchange where the Share Class is listed, placing an order on the Secondary Market will trigger costs over which the Management Company has no influence. Please note that shares that are purchased on the Secondary Market cannot generally be sold back directly to the Company. As a result, investors operating on the Secondary Market may incur intermediary and-or brokerage and-or transaction fees on their transactions, over which the Management Company has no influence.

These investors will also trade at a price that reflects the existence of a bid-ask spread. Such investors are invited to contact their usual broker for further information on the brokerage fees that may apply to them and the bid-ask spreads they are likely to incur. Finally, the Board has decided that all the remaining Shareholders will be compulsory redeemed as of June 12, 2024, at the final Net Asset Value of June 12, 2024 calculated on June 13, 2024. Any proceeds which cannot be distributed to Shareholders will be deposited on their behalf with the Caisse de Consignation in Luxembourg.
