Derived from the Relevant Event announced on July 14, 2016, where the company **QIHOO 360 TECHNOLOGY CO. LTD.** with ticker **QIHU** will be acquired by a group of companies: **CITIC Securities Co Ltd, Golden Brick Capital Private Equity Fund I LP, China Renaissance Holding Ltd y Sequoia Capital, among others**, the constituent list of the **CHINA SX20 and CHINA SX20 RT** indices will be changed on **Monday July 18, 2016**, the same day that the company will be suspended from NYSE; the change of samples will be realized according with the section "Revision and Permanence of the Constituent List" of the methodology, therefore, the shares of **QIHU** will be removed from the corresponding samples and company **ALUMINUM CORPORATION OF CHINA** with ticker **ACH** will be included.
