S&P DJI and the Mexican Stock Exchange Select RobecoSAM as the Official Score Provider for Future S&P BMV ESG Indices

Mexico City, February 12, 2019 -- S&P Dow Jones Indices (S&P DJI) and the Mexican Stock Exchange (BMV Group) announced that RobecoSAM will be the official score provider for S&P/BMV Environmental, Social and Governance (ESG) index products that will be created and launched in the future under the existing partnership agreement.

RobecoSAM has been S&P DJI's first ESG research, data and expert since 1999, when the first Dow Jones Sustainability indices were launched. RobecoSAM was founded in 1995 and is now one of the world's leaders in sustainable investing and research.

"We are excited to utilize RobecoSAM's sustainability data and analytics on future S&P/BMV ESG indices in Mexico. S&P DJI already offers a wide range of smart beta ESG, carbon efficient and fossil-fuel free indices. This latest development helps enhance our current offerings in the Latin American market," said Silvia Kitchener, Product Management Director, at S&P DJI.

"We are thrilled that RobecoSAM becomes the new ESG evaluator for the companies listed at the Mexican Stock Exchange as of 2019, the transition to a globally recognized evaluator is part of the migration processes and international best practices, that the BMV Group sought for the Mexican indexes by partnering with S&P DJI" said José-Oriol Bosch, CEO at BMV Group.

Under this arrangement companies listed on the Mexican Stock Exchange will be assessed as part of RobecoSAM's Corporate Sustainability Assessment (CSA), an annual evaluation of corporate sustainability practices. Click [here](#) for the 2019 timeline of the DJSI/CSA annual review.

Aiming to work closely during the transition to the new score provider, BMV will host a workshop for its listed companies, along with RobecoSAM representatives, to address questions about the review process. A separate announcement will follow with details on the date and venue.

Separately, the existing S&P/BMV IPC Sustainable Index, one of the S&P/BMV ESG indices will continue with its regularly scheduled annual rebalancing on March 2019 using its current methodology and scores provided by the University of Anahuac. The S&P/BMV IPC Sustainable Index is designed to measure the performance of Mexico's leading companies based on economic, environmental and social criteria.
