Rotoplas Updates on response to COVID-19

Grupo Rotoplas S.A.B. de C.V. (BMV: AGUA) ("Rotoplas" or "the Company"), the leading water solutions company in the Americas, announces its continuous commitment to its stakeholders in order to help them face the current sanitary crisis.

Some plants and distribution centers have undergone changes in their operations as they had to close by official mandate as a preventive measure to stop the spreading of the disease. The status of our current operations is as follows:

| Country or region | Manufacturing plant/distribution center situation |

| Mexico | Continuous operations |
| Argentina | Limited operations – plants are only allowed to open to fulfill priority orders |
| USA | Normal operation of the e-commerce platform |
| Peru | Closed since March 16th |
| Central America | Guatemala, El Salvador, Costa Rica and Nicaragua have continuous operations. The distribution center in El Salvador is open and the one in Honduras is closed since March 16th |

At the financial level, on April 30th we announced the divestment of the product unit in Brazil strengthening our cash position in around USD\$7 million and an expected 60bp improve on the ROIC. The increasing necessity of water solutions and being considered an essential industry, primarily in Mexico, United States of America and Central America has helped the resiliency on sales despite the mobility restrictions.

Maintaining a strong balance sheet to withstand the inherent volatility of the markets and economies in which we operate is our main focus. We monitor on a weekly basis the liquidity position through the cash control tower.

The Company reiterates and reinforces its commitment to supporting vulnerable communities, environmental responsibility and improving the quality of life of people inside and outside the company. This has helped us to be appointed as a socially responsible company for the tenth year in Mexico and third year in Peru. The commitment to ESG goals is a guiding principle for our corporate culture and it is also integrated into the performance objectives of senior management.



Rotoplas' products and services play an important role in preserving people's health and helping combat the spreading of the COVID-19. As of this day we have donated more than 5,000 water storage products, across the regions where we operate, to be used in handwashing stations and for consumption purposes. We have also donated IoT sensors to measure water levels in some handwashing stations installed outside hospitals and a yearlong bebbia service of 20 purification points also for a hospital in Mexico City.
