

## **GENTERA** announces short term debt issuance in its Peruvian subsidiary.

Mexico City, Mexico, February 06, 2025 – Gentera, S.A.B. de C.V. (GENTERA) (BMV: GENTERA\*) informs that its subsidiary, Compartamos Financiera (now Compartamos Banco Perú), which operates in Peru, successfully placed the amount of 56.2 million soles, through the public issuance of Certificates of Deposit in the Peruvian debt market.

This issuance has a term of 1 year, with a rate of 4.71875%, and had a 3.51 times oversubscription.

Through this transaction, Compartamos reaffirms its ability to access diverse funding sources, strengthening its commitment to providing accessible and tailored financial solutions for its clients while expanding its reach to new communities. In doing so, it continues to establish itself as a key player in financial inclusion in the country.
