

GENTERA informs the actions taken by S&P Global Ratings over Banco Compartamos' ratings.

Mexico City, March 27th, 2020 – GENTERA S.A.B. de C.V. (BMV: GENTERA*) informs that **Banco Compartamos S.A. I.B.M.**, GENTERA's main subsidiary, was informed about changes in its National Scale Rating and on its Global Scale by **S&P Global**, maintaining the 'Negative' outlook.

S&P Global Ratings made the following changes in Banco Compartamos' ratings:

- Modified the Global Scale to 'BBB-/Negative/A-3' from 'BBB/Negative/A-2'
- Modified the National Scale to 'mxAA+' / Negative / 'mxA-1+' from 'mxAAA' / Negative / 'mxA-1+'
- Modified the National Scale to 'mxAA+' from 'mxAAA' issue-level rating on Banco Compartamos' senior unsecured debt.

S&P Global Ratings issued a press release today, which stated the following:

".....Our ratings actions reflect various aspects about how the sovereign ratings and our BICRA affect our view of financial institutions we rate that operate in Mexico. Furthermore, the rating actions reflect the relative strengths or weaknesses of each financial institution's stand-alone credit profile (SACP) ..."

GENTERA was established in 2010 and is headquartered in Mexico. Its shares began trading on the Mexican Stock Exchange on December 24, 2010 under the ticker symbol COMPARC*. On January 2, 2014, the ticker symbol was changed to GENTERA*.
