

GENTERA informs that Banco Compartamos was affirmed in its Investment Grade by S&P Global Ratings.

Mexico City, May 29th, 2018 – GENTERA S.A.B. de C.V. (BMV: GENTERA*) informs that **Banco Compartamos S.A. I.B.M.**, GENTERA's main subsidiary, was affirmed in its National Scale Rating and on its Global Scale by **S&P**, maintaining the 'Negative' outlook.

S&P Global Ratings took the following actions:

- Affirmed the global scale 'BBB/A-2' rating to Banco Compartamos, maintaining the 'Negative' outlook.
- Affirmed the national scale 'mxAAA/mxA-1+' rating.
- Affirmed the national scale 'mxAAA' issue-level rating on Banco Compartamos' senior unsecured debt.

S&P Global Ratings issued a press release today, which stated the following:

"...The ratings on Compartamos reflect its leading position in Mexico's microfinance sector, diverse customer base, and the wide geographical footprint. These factors provide the bank resilience to economic downturns. We also view Compartamos' capitalization levels as credit strength with a RAC ratio of about 16.4% for the next 24 months...."
