Mexico City, June 7th, 2018. Crédito Real, S.A.B. de C.V., SOFOM, E.N.R. ("Credito Real"), announces today that the Company repurchased 175,000 shares at market price, through its stock buyback program. The foregoing, with the aim to strengthen the Company's positioning in the stock market under the current economic-financial environment.

In this context, it is important to note that Credito Real's General Ordinary Shareholders' Meeting, held on April 25th, 2018, approved, among other points, the maximum amount of resources that may be allocated to the purchase of the Company's own shares during fiscal year 2018 for a sum equivalent to the balance of the Company's net profits, including retained earnings as of year-end 2017.
