USNWDIVS A DevonEnergy Announces Capital Return Update May 07, 2026 16.30 ET Source.Devon Energy Corporation HOUSTON, May 07, 2026 (GLOBE NEWSWIRE) DevonEnergy Corporation ( Devon ) (NYSE.DVN) today announced a series of capital return actions following the successful completion of its previously announced all.stock merger with Coterra Energy Inc. ( Coterra ) earlier today. The actions reflect the board s confidence in the combined company s free cash flow generation and its commitment to delivering differentiated returns to shareholders through commodity cycles. DIVIDEND APPROVAL Devon s board of directors has approved a quarterly fixed dividend of USD0.320 per share, approximately 1.6PCT above the company s previously stated expectations of USD0.315 per share, and a 33PCT increase over the prior quarter. The dividend is payable on June 30, 2026 to shareholders of record as of the close of business on June 15, 2026. Devon expects to evaluate growing its dividend on an annual cadence.
